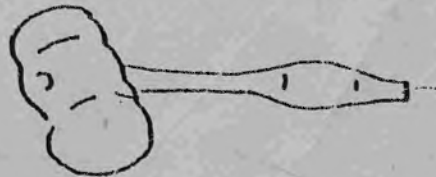
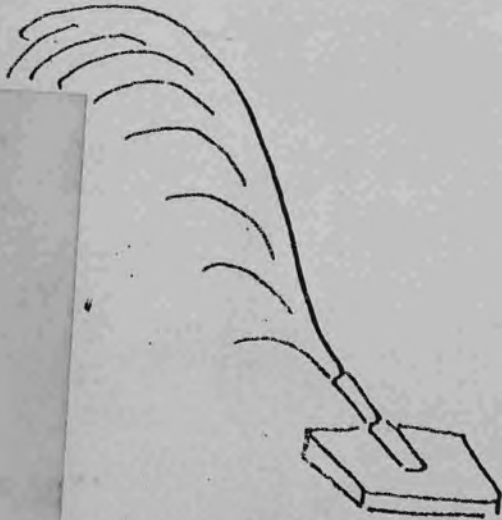

- 108 Jacob Cornegys guardian of Edna Cornegys. This is a bill for misc. We find clothing, Kaskia shoes, a quire of paper, boarding at Mr. ---- Ross for six months at school. Mrs. Paddock, Miss Ward, and cash for a show at Col. Audrains. The store was V.J. Peer- and Co.
- 109 William Hays, Adm. of William Hays dec'd.. shows money from Isaac Vanbibber, Joshua Dodson, Boon Hays. (Sorry, he paid these.)

Falconer, these for negro hire they owe. Wm. Mason paid for the rent of the mill and gin.
- 135 Beauchamp makes accounts.
- 136 Benjamin Burdyne, Adm. of Elizabeth Burdyne dec'd. Shows a note with Amos Burdyne and Felix Scott to estate. Last settlement was 1825. Hire of a negro Jim shown. Heirs; Susannah Brindle, Catherine Chamberline, Sarah Burdyne, Elizabeth Burdyne, Elizabeth Chamberlin, Amos Burdyne, the heirs of Nancy Smith. and Agnes Dicken.
- 137 The boy named Doe, apprenticed to Samuel K. Taylor, tanner.
- 138 30 May 1828; Abigail Robbins, surviving executor of the last will and testament of Moses Robbins, to appear in court, for further security.
- 139 Thomas Caulk to receive from Seth Millington, for the heirs of James R. Estes money.
- 140 Welcome A. Robbins and Moses B. Robbins appear in court with settlement of the estate of Thaddeus C. Robbins dec'd.. (The money due on sale bill was due October 1824). Banks shown are; Bank of Missouri, Urbana Banking Company, Missouri Exchange Bank, The Bank of Owensville and Missouri Loan Office. Other names mentioned are; Jethro Sumner, Wm. C. Christy Jr., Wiley White, David Mc Dowell, Celah or Caleb Perry.
- 141 Thomas Caulk, Adm. of James Flaugherty Jr. dec'd.. settlement. (Shows he attended courts in 1823,1825,1826 for various things) There is an income from Miami Exporting Company The estate paid John Mc Coy and Edward Charless among others.
- 142 August Term 1828; William G. Pettus Esq., is appointed Justice of Court. William N. Fulkerson is appointed as Sheriff.
- 143 William T. Lamme and Morgan Bryan appear with settlement, estate of John B. Callaway. Shows names; W. Dillons (furnisings for heirs) and R. Rankin for the same and Nathan Browning.
- 144 Cornoyer estate; Paid; Mr. Verhagen, James Fulkerson, Wm. Lynch, Edw. Charles, Hypolite Bernard, Etinne Bernard, William Christy, Charles Paschall, R. Spencer and Andrew Wilson.
